RESOLUTION TO APPROVE AND AUTHORIZE THE AWARD OF A CONTRACT TO AHERA CONSULTANTS, INC. FOR ASBESTOS REMEDIATION

WHEREAS, the Housing Authority of the City of Linden ("Housing Authority"), a public

entity organized and existing pursuant to the Code of Federal Regulations, the U.S. Department of

Housing and Urban Development ("HUD"), and the laws of the State of New Jersey, has

determined that it is in need of asbestos remediation services; and

WHEREAS, specifically, Housing Authority vendor LEW Corporation performed a

survey for asbestos containing materials and discovered such materials in pipe joints and joint

compounds within the Housing Authority's office spaces; and

WHEREAS, LEW Corporation recommended the removal of all asbestos containing

materials prior to any renovations to the office area; and

WHEREAS, the Housing Authority therefore desires to secure the services of a properly

EPA licensed asbestos contractor to remove and properly dispose of all asbestos containing

materials from the office spaces prior to any renovations; and

WHEREAS, AHERA Consultants, Inc. has the capability to provide asbestos remediation

services; and

WHEREAS, therefore, the Housing Authority wishes to award a contract to AHERA

Consultants, Inc. for asbestos remediation services; and

WHEREAS, the Housing Authority's Qualified Purchasing Agent, Ann Marie Whelan, has certified that this procurement is in compliance with all applicable Federal and State of New Jersey procurement requirements, including but not limited to the Federal Procurement Standards (2 C.F.R. 200.317 et seq.), the HUD Procurement Handbook (HUD Handbook 7460.8), the New Jersey Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.), and the New Jersey Procurement Regulations (N.J.A.C. 5:34-1.1 et seq.); and

WHEREAS, the Board of Commissioners has determined that it is in the best interest of the Housing Authority and its overall goal of providing quality, affordable housing to low-income seniors to approve and authorize the award of a contract to AHERA Consultants, Inc. for asbestos remediation;

## NOW THEREFORE,

**BE IT RESOLVED**, that the Board of Commissioners of the Housing Authority of the City of Linden hereby approves and authorizes the award of a contract to AHERA Consultants, Inc. in the amount of \$5,200.00 for asbestos remediation; and

**BE IT FURTHER RESOLVED**, that the Board hereby directs the Executive Director of the Housing Authority to take any and all necessary administrative actions to implement this resolution.
