**RESOLUTION TO RATIFY THE AWARD OF A CONTRACT TO C3  
INVESTIGATIONS FOR CONFIDENTIAL INVESTIGATION SERVICES**

**WHEREAS**, the Housing Authority of the City of Linden (“Housing Authority”), a public entity organized and existing pursuant to the Code of Federal Regulations, the U.S. Department of Housing and Urban Development (“HUD”), and the laws of the State of New Jersey, determined that it was in need of confidential investigation services; and

**WHEREAS**, specifically, the Housing Authority determined that confidential investigation services were needed on an urgent basis; and

**WHEREAS**, the Housing Authority determined that C3 Investigations was duly qualified to perform the required services; and

**WHEREAS**, therefore, the Housing Authority wished to award a contract to C3 Investigations for confidential investigation services; and

**WHEREAS**, the QPA of Record certified that the procurement of C3 Investigations was compliant with all Federal and State of New Jersey procurement requirements; and

**WHEREAS**, the Housing Authority certified that sufficient funds were appropriated for the above-mentioned services; and

**WHEREAS**, the Board of Commissioners has determined that it is in the best interest of the Housing Authority and its overall goal of providing quality, affordable housing to low-

income seniors to ratify the award of a contract to C3 Investigations for confidential investigation services;

**NOW THEREFORE,**

**BE IT RESOLVED** that the Board of Commissioners of the Housing Authority of the City of Linden hereby ratifies the award of a contract to C3 Investigations for confidential investigation services; and

**BE IT FURTHER RESOLVED** that the Board hereby authorizes the Interim Executive Director of the Housing Authority to take any and all necessary administrative actions to implement this resolution.
