**RESOLUTION TO APPROVE AND AUTHORIZE THE AWARD OF A CONTRACT
TO C3 INVESTIGATIONS FOR CONFIDENTIAL INVESTIGATION SERVICES**

WHEREAS, the Housing Authority of the City of Linden (“Housing Authority”), a public entity organized and existing pursuant to the Code of Federal Regulations, the U.S. Department of Housing and Urban Development (“HUD”), and the laws of the State of New Jersey, has determined that it is in need of additional confidential investigation services; and

WHEREAS, specifically, the Housing Authority has determined that additional confidential investigation services are needed on an urgent basis; and

WHEREAS, the Housing Authority has determined that C3 Investigations is duly qualified to perform the required services; and

WHEREAS, therefore, the Housing Authority wishes to award a contract to C3 Investigations for confidential investigation services; and

WHEREAS, the QPA of Record has certified that the procurement of C3 Investigations is compliant with all Federal and State of New Jersey procurement requirements; and

WHEREAS, the Housing Authority has certified that sufficient funds have been appropriated for the above-mentioned services; and

WHEREAS, the Board of Commissioners has determined that it is in the best interest of the Housing Authority and its overall goal of providing quality, affordable housing to low-

income seniors to approve and authorize the award of a contract to C3 Investigations for additional confidential investigation services;

NOW THEREFORE,

BE IT RESOLVED that the Board of Commissioners of the Housing Authority of the City of Linden hereby approves and authorizes the award of a contract to C3 Investigations for additional confidential investigation services; and

BE IT FURTHER RESOLVED that the Board hereby authorizes the Interim Executive Director of the Housing Authority to take any and all necessary administrative actions to implement this resolution.
