## RESOLUTION TO APPROVE AND AUTHORIZE THE AWARD OF A CONTRACT TO CURRENT ELEVATOR TECHNOLOGY, INC. FOR THE ELEVATOR MODERNIZATION PROJECT

WHEREAS, the Housing Authority of the City of Linden ("Housing Authority"), a public entity organized and existing pursuant to the Code of Federal Regulations, the Department of Housing and Urban Development ("HUD"), and the laws of the State of New Jersey, has determined that it is in need of modernizing its elevators; and

WHEREAS, the cost of the elevator modernization was expected to exceed the bid threshold of \$44,000.00 under the New Jersey Local Public Contracts Law; and

WHEREAS, pursuant to N.J.S.A. 40A:11-4 and 2 C.F.R. 200.320(b)(1), the Housing Authority published a public advertisement for bids; and

WHEREAS, in accordance with the public advertisement, bids were due by 2:00 p.m. on November 29, 2023; and

WHEREAS, the Housing Authority received a total of six (6) bids by the published deadline; and

WHEREAS, following a public bid opening and subsequent review of all bids received, Current Elevator Technology, Inc., with a total bid of Seven Hundred Thirty Six Thousand Three Hundred and 00/100 Dollars (\$736,300.00), was found to be the lowest responsible bidder pursuant to N.J.S.A. 40A:11-4 and N.J.S.A. 40A:11-2; and

and deemed by the Housing Authority's architectural and engineering firm and legal counsel to be responsive and conforming with all requirements as set forth by Federal procurement law, New Jersey Local Public Contracts Law, the public advertisement for bids, and the bid package; and

WHEREAS, the contract is being awarded pursuant to a "fair and open" process in accordance with N.J.S.A. 19:44A-20.5; and

WHEREAS, the Housing Authority has certified that sufficient funds have been appropriated for the above-mentioned project; and

WHEREAS, the Board of Commissioners has determined that it is in the best interest of the Housing Authority and its overall goal of providing quality, affordable housing to low-income seniors to approve and authorize the award of a contract to Current Elevator Technology, Inc. for the elevator modernization project;

### NOW THEREFORE,

**BE IT RESOLVED**, that the Board of Commissioners of the Housing Authority of the City of Linden hereby approves and authorizes the award of a contract to Current Elevator Technology, Inc. in the amount of \$736,300.00 for the elevator modernization project, subject to the bidder's successful completion of all post-bid matters; and

**BE IT FURTHER RESOLVED**, that the Board hereby directs the Interim Executive Director of the Housing Authority to take any and all necessary administrative actions to implement this resolution.
