**RESOLUTION TO APPROVE AND AUTHORIZE THE AWARD OF A CONTRACT
TO SUNBELT INDUSTRIES, INC. FOR HOUSING INSPECTION SERVICES**

WHEREAS, the Housing Authority of the City of Linden (“Housing Authority”), a public entity organized and existing pursuant to the Code of Federal Regulations, the Department of Housing and Urban Development (“HUD”), and the laws of the State of New Jersey, has determined that it is in need of housing inspection services; and

WHEREAS, pursuant to the New Jersey Local Public Contracts Law and Federal procurement regulations, the Housing Authority published a Request for Proposals (“RFP”) for housing inspection services; and

WHEREAS, in accordance with the terms of the RFP, all proposals were to be received by 11:00 a.m. on January 25, 2024 and were to be objectively evaluated based upon a number of factors specified therein; and

WHEREAS, the Housing Authority received proposals from two (2) respondents by the published deadline; and

WHEREAS, following a thorough analysis of all such proposals in accordance with the published criteria, the Housing Authority has determined that the proposal submitted by Sunbelt Industries, Inc. was fully responsive, meets all the needs and requirements of the Housing Authority, and is the most advantageous to the Housing Authority, price and other factors considered; and

WHEREAS, wherefore, the Housing Authority wishes to award a contract to Sunbelt Industries, Inc. for housing inspection services; and

WHEREAS, the contract is being awarded pursuant to a "fair and open" process in accordance with N.J.S.A. 19:44A-20.5; and

WHEREAS, the Housing Authority has certified that sufficient funds were appropriated for the above-mentioned services; and

WHEREAS, the Board of Commissioners has determined that it is in the best interest of the Housing Authority and its overall goal of providing quality, affordable housing to low-income seniors to approve and authorize the award of a contract to Sunbelt Industries, Inc. for housing inspection services;


NOW THEREFORE,

BE IT RESOLVED, that the Board of Commissioners of the Housing Authority of the City of Linden hereby approves and authorizes the award of a contract to Sunbelt Industries, Inc. for housing inspection services, subject to the respondent's successful completion of all post-RFP matters; and

BE IT FURTHER RESOLVED, that the Board hereby directs the Interim Executive Director of the Housing Authority to take any and all necessary administrative actions to implement this resolution.
